## 3. Timetable and Reporting

The Study shall commence on June 30th 2020 and be completed on October 31st, 2027.

MARDC shall provide UZH with regular written reports on the status of the Study every 6 months. Within sixty (60) days after the completion or termination of a Study, MARDC shall provide UZH with copies of all laboratory data (if applicable) and results relating to the Study ("Records") including a final report summarizing the data and results ("Report").

## Appendix B

## Compensation
