GUIDELINES FOR ADMISSION OF INTERNATIONAL STUDENTS

As the new education policy is implemented and taking shape and Government of India wants India to be projected as the education hub. Thus, we are in a process of forming an international student cell to facilitate the admission of future international students. At present this facility can be availed by NRI candidate after successfully clearing the NEET examination. Following are the general guidelines for admission of international students.

1. Should be an international student (Foreign student/ Non-Resident Indian)
2. Foreign students require a mandatory student visa. However, for NRI this is not a mandatory requirement.
3. Students have to obtain prior security clearance from the Ministry of Home Affairs and the approval of Department of Higher Education, Ministry of Human Resource Development, Government of India, and this must be on the student visa /research visa endorsed to the college.

ELIGIBILITY:

Eligible candidates include OCI foreign students, Person of Indian Origin (PIO) card holders, Non-Resident Indian (NRI) and NRI sponsored candidates (sponsored by NRI parents, brother/sister of parents, brother/sister of the candidate, grandparents or spouse of the candidate). Only those candidates who have qualified from foreign universities or boards of higher education recognized as equivalent by "Association of Indian Universities" (AIU) are eligible for admission.



PROCEDURE FOR ADMISSIONS:

1. The students shall qualify in the NEET examination for admission into BDS and MDS programs.
2. The candidate may contact the Admission Committee, M.A. Rangoonwala College of Dental Sciences and Research Centre, Pune.
3. Get the "Provisional Admission Offer Letter" from the Principal's office , in order to obtain the student/research visa (on payment of the non-refundable advance amount of 30% of the total annual fee).
4. Submit the "Provisional Admission Offer Letter" to the Indian Embassy of the respective country for obtaining the student visa.
5. Report at the college for admission.
6. Submit the below mentioned documents and get them verified by the admission committee.
 - Passing Certificate/Equivalence Certificate of the qualifying examination.
 - Mark list of the qualifying examination.
 - Student visa in original.
 - A photocopy of the passport duty attested by the Notary.
 - Students are required to undergo the medical fitness examination and get the medical fitness certificate. As per government rules, all international students entering India on 'student visa' have to be tested for HIV.
 - For applicants who have undertaken their studies in a language other than English need to have a valid IELTS/TOEFL score.

DISCIPLINE:

The international students should abide by all the rules and regulation of the college and the code of conduct as applicable to Indian students enrolled in the same courses.



EXAMINATION AND AWARD OF DEGREES AND DIPLOMAS:

The procedure for examination, payment of examination fees, issue of mark list , issue of passing certificates , award of degrees and diplomas will be the same as for the Indian students undertaking the same courses.

Admission of international/NRI students will be confirmed after verification of original certificates, medical fitness test and payment of required fees. Even after the admission, at any stage, if it is noted that the qualifying certificate is not recognized , the admission of the candidate may be cancelled.
