

This MoU is made on 17" day of February 2015 and executed between Yenepoya University, Deralakatte, Mangalore – 575 018 (First Party) and M.A. Rangoonwala College of Dental Sciences & Research Centre, Pune (Second Party)

- The expression and thoughts of both the parties shall be final with respect to this MoU
- 2 The purpose of this MoU is to enter into Collaborative Research with the Second party on the projects undertaken by students and Faculty of both the parties including those who register for Ph.D. The Research work shall be done at both the institutions utilizing the facilities available within the framework of UGC Regulations.
- There will be no expenditure from the First Party side as the research fund will be generated by the Second Party
- 4. Ph.D candidates of Second Party will abide by the rules and regulations with regard to Ph.D programme and do course work prescribed by the Yenepoya University and will have personal interaction with the Guides of First Party
- 5 The following action plan be taken:
 - a. Application by the Centre for Research Collaboration shall be recognized by the Yenepoya University, along with the details of the Centre and the facilities available as well as biodata of potential Ph.D Guides.
 - b. Visit of senior executives of the Yenepoya University to the Centre for Research Collaboration to inspect the facilities available at the Centre.
 - c. Recognition of the Centre for Research Collaboration by the Yenepoya University authorities for research collaborations.
 - Recognition of the eligible co-guides available at Centre for Research Collaboration by the Yenepoya University.
 - e. Registration of the Ph.D students as per the Yenepoya University rules
 - f The Ph.D student will have one Guide at the Yenepoya University and one Co-Guide from the Research Centre

- g. The candidate who have registered for Ph.D shall pass the preliminary examination conducted by the Yenepoya University within the prescribed time limit.
- h. All the rules of the Ph.D programme, as amended from time to time by the Yenpoya University will be applicable to these students at the Research Centre.

That both the parties will endeavor to settle any controversy disputes differences or claims whatsoever related to the AGREEMENT including the existence, validity interpretation, performance, termination or breach thereof, by arbitration through a Sole. Arbitrator to be appointed by the "First Party". The Arbitration and Conciliation Act 1996, shall govern the arbitration proceedings.
